Care and Cleaning Instructions

Equinox® Louvered Roof systems are easy to maintain. Generally, normal rainfall is sufficient to keep its appearance clean. If cleaning is required, we recommend the following steps. Particular attention should be given to areas under eaves, porches, awnings, and other overhangs that have limited exposure to the natural cleansing effect of rainfall.

1) For moderate dirt – An occasional washing with clear water using a garden hose and soft-bristled brush is recommended (a long-handled, car-washing brush is ideal for this purpose).

2) For a heavier dirt accumulation – Wash in the manner indicated above, but use the following solution:

- 1/3 cup detergent (e.g., Tide®)
- 2/3 cup trisodium phosphate (e.g., Soilax®)
- 1 gallon water

3) Mildew accumulation – Mildew can collect on surfaces of all types of building products and is often evident on surfaces that have not been properly maintained. Normally, mildew will appear as black spots. Mildew is easy to remove by using the following cleaning solution:

- 1/3 cup detergent (e.g., Tide®)
- 2/3 cup trisodium phosphate (e.g., Soilax®)
- 1 quart sodium hypochloride 5% solution (e.g., Clorox®)
- 3 quarts water

4) Environmental black streaking – Black streaking can also collect on the surface of a structure. Black streaking can be removed by using Gutter Zap 4, which can be purchased from the dealer that installed your unit.

5) Caulking compounds, tar, etc. – Use mineral spirits in reasonable amounts; apply directly to foreign substance. Rinse the area thoroughly with water immediately after cleaning.

Equinox Louvered Roof Manufacturer's Warranty

Amerimax Exterior Home Products, Norcross, Georgia (hereinafter referred to as "Amerimax") provides the following limited material warranty for the Equinox® Louvered Roof which is installed at the location shown on this warranty certificate. This warranty is subject to limitations, exclusions and conditions as detail in this warranty certificate.

- The louvers and all support components (beams, gutters and posts) are warranted for ten (10) years from the date on installation against defects in materials and workmanship under normal use and service.
- The power components (motor, solar panel, link bar, electronic controls) are warranted for three (3) years (parts replacement only) from the date of installation. Batteries are excluded from this warranty.
- This warranty is offered only to the original retail purchaser and is not transferable.
- The warranty only applies to manufacturing defects in the products. Steel products are not warranted against rust. The warranty covers residential and commercial applications.

Claims Procedure

Any claim under this warranty must be in writing and sent to Amerimax Exterior Home Products, 303 Research Drive, Suite 400, Norcross, Georgia 30092 and received within 30 days of discovering claimed defect. This written notification must include a description of the defect, the address of the installed product, plus the date of installation, and the name and address of the contractor who installed the product. As Amerimax must have a reasonable opportunity to inspect the claim, do not begin any repairs prior to said inspection or the terms of the warranty could be voided.

- 1) If, after inspection by Amerimax it is determined that said defect is covered by the warranty, Amerimax shall have one hundred twenty (120) days to deliver to you a refund, repair, or new products to remedy the defective product as follows:
- 2) During the first (1) year of installation, Amerimax has the option to repair, refinish, or replace the defective product at no cost to the homeowner, except for power components.
- 3) From the second (2) year through the tenth (10) year,

Amerimax has the option to repair, refinish, or replace defective product, but the homeowner is responsible for the labor and product shipping charges.

Amerimax shall not be liable for any shipping, labor, removal, or installation costs to remedy the defective products following the first year of the warranty period.

Exclusions and Limitations

Amerimax does not warrant the qualifications of the person installing its products. Also, this warranty does not cover installation or any consequences of faulty installation, normal weathering, chalking, fading, corrosive atmosphere contaminated with chemical fumes or salt, or any act of God, explosions or other causes beyond the control of Amerimax. This warranty does not cover the louvers being weather tight. It is important that the homeowner follows the Care and Cleaning Instructions outlined on the back of this page. Amerimax does not warrant when aggressive environmental conditions are manifested. That includes, but not limited to, black streaking on the beams and louvers.

This warranty shall not be valid or enforceable unless it is registered with Amerimax within thirty (30) days after completion of the original installation of the product covered herby and on the registration form attached hereto.

Amerimax reserves the right to discontinue and make changes in any of its products. In the event that products covered by this warranty are not available, Amerimax shall have the right to substitute products that in Amerimax's discretion are of comparable grade, quality, or price. This limited warranty only applies to products erected within the continental United States and Canada.

THE LIMITED WARRANTY IS MADE IN LIEU OF ALL OTHER WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE WHICH ARE DISCLAIMED AND THE PURCHASER'S RIGHTS ARE LIMITED TO THE TERM OF THIS WARRANTY. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. Amerimax shall not be liable for any incidental, special or consequential damages, so the above limitations or exclusion may not apply to you. The obligations of Amerimax set forth herein are the sole remedies available whether the claim is for negligence, breach of warranty. This warranty gives you specific legal rights, you also may have other rights which may vary from state to state.
